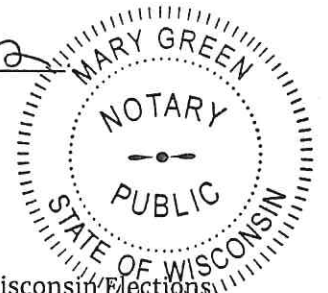

ORDER FOR RECOUNT

On April 8, 2022, a recount petition was filed by Philip R. Kasun, a candidate for the office of Alderperson for the 6th District, at the Spring Election held on April 5, 2022.

2. The boards of canvassers convene at 9:00 AM on April 13, 2022 at Delafield City Hall, Common Council Chambers, 500 Genesee Street, Delafield, WI 53018, to begin the recount.
3. The recount be completed by the board of canvassers immediately.
4. The clerk transmit a certified canvass report of the result of the recount and a copy of the minutes of the recount proceedings to the Wisconsin Elections Commission immediately after the completion of the recount.
